The average rate of return on investments this quarter:

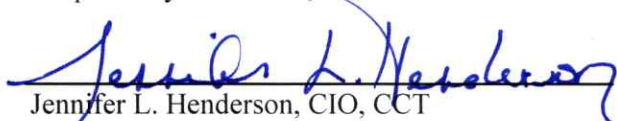
