(7) SCHLEICHER COUNTY ISD TRACK PROPOSAL

County Judge Charlie Bradley presented the high points that officials and department heads felt needed some revision. County Attorney Clint Griffin explained that the majority of the changes in language were due to necessary changes mandated by our insurance policies. Discussion only, no action taken.

(13) INTERLOCAL AGREEMENT WITH TOM GREEN COUNTY FOR JAIL SERVICES

Sheriff Jason Chatham presented that we have contracted with TGC in prior years, the rate was \$70 per day, now changing to \$80 per day. Asking the court to approve the agreement with the increase to continue housing inmates in Tom Green County when necessary. Motion to approve the agreement by Commissioner Steve Nelson. Seconded by Commissioner Chris Meador. Motion passes.

(14) INTERLOCAL AGREEMENT FOR E911 PSAP

County Judge Charlie Bradley presented the agreement, the equipment is housed at the sheriff's office. Motion to approve the agreement by Commissioner Steve Nelson. Seconded by Commissioner Gary Gibson. Motion passes.

(15) CONTRACT FOR DETENTION SERVICES WITH TGC JUVENILE DETENTION CENTER

County Judge Charlie Bradley presented the contract. It is time to renew our contract for juvenile services. Motion to approve the contract by Commissioner Chris Meador. Seconded by Commissioner Gary Gibson. Motion passes.

(16) INTERLOCAL COOPERATION AGREEMENT DETENTION EXPANSION PROJECT SERVICES WITH TGC JUVENILE DETENTION CENTER
