The Commissioners' Court in and for the County of Schleicher met for a Regular Meeting this, the 10th day of November 2025, with the Commissioners Gary Gibson, Steve Nelson, Kirk Griffin, and Chris Meador present when the following proceedings were had to wit.

**(1) THE PLEDGE OF ALLEGIANCE**

Led and recited by County Judge Charlie Bradley.

**(2) DETERMINATION OF QUORUM AND CALL TO ORDER**

Quorum determined and meeting called to order at 9:04 a.m.

County Judge Charlie Bradley mentioned that several members of Hill Country staff was present to share updates on the mobile mental health clinics that are now available.

**(8) CYBER POLICIES**

Treasurer Henderson recommends option two which suits the needs of our county more appropriately. There are available funds in miscellaneous of the general fund. \$11,700 annually, the county will revisit the policy once every three years. Motion to accept and approve option two by Commissioner Chris Meador. Seconded by Commissioner Gary Gibson. Motion passes.

**(9) BANK DEPOSIT BIDS**

Treasurer Henderson briefly discussed the changes in the language of the contract with the court. Motion to accept as presented by Commissioner Kirk Griffin. Seconded by Commissioner Chris Meador. 4 ayes, 1 nay. Motion passes.

**(10) MOU WITH SUTTON COUNTY SHERIFF'S OFFICE**

Memorandum was previously presented by County Sheriff Jason Chatham. Asking the court to ratify the acceptance. Motion to ratify by Commissioner Gary Gibson. Seconded by Commissioner Steve Nelson. Motion passes.

**(11) SCHLEICHER CAD BOARD OF DIRECTORS 2026-2027**

County Judge Charlie Bradley reviewed that the court had agreed to add Commissioner Chris Meador and Commissioner Steve Nelson to the ballot. 2,602 votes are allotted for the county. Motion to vote 1,301 votes to each by Commissioner Kirk Griffin. Seconded by Commissioner Gary Gibson. Motion passes. Commissioner Chris Meador and Commissioner Steve Nelson will each receive 1,301 votes.

**(12) SCHLEICHER COUNTY BURN BAN**

Motion to approve and activate the countywide burn ban by Commissioner Chris Meador. Seconded by Commissioner Steve Nelson. Motion passes.

**(13) TDEM GRANT FORMS**

County Judge Charlie Bradley mentioned that forms were received two weeks ago. Motion to appoint County Judge as the first signor and County Treasurer as secondary signor, and Treasurer Henderson as head of finance by Commissioner Kirk Griffin. Seconded by Commissioner Chris Meador. County Judge Charlie Bradley abstained. Motion passes

**(14) COUNTY ROAD DEPARTMENT/EQUIPMENT/MATERIALS**

Commissioner Chris Meador mentioned that proposals had been sought for road repairs in Precincts 1 and 4. Members of the public have started complaining about the condition of several county roads. Motion to approve proposals for contracted repairs on County Roads 113, 114, and 427 by Commissioner Kirk Griffin. Seconded by Commissioner Steve Nelson. Motion passes.
